# SWOG Policy #33

- Institutional Performance Review Updates
  - Address evolving data requirements
  - Align our performance measures with the DQP
  - Bridge gaps identified in the review process
- IFS (Initial Forms Set):
  - **Expand** to include all baseline forms, reports, **specimens** and source documents
- Follow-Up:
  - **Consolidate** 'follow-up, on tx' and 'follow-up, off tx' measures
  - **Rename** into 'Vital Status Update'

# IPR Recommendations

- Post-baseline Forms:
  - ***Include post-baseline forms***, report or other protocol-specified document that has an outstanding expectation within the last 13 months
- Specimen Submission:
  - ***Include post-baseline specimens*** for which an expectation has been posted

\*\*\* If approved by the Board of Governors, sites will be given adequate time to respond to any additional data submission requirements. SWOG will send formal notification with details. \*\*\*

I am reaching out regarding your site's participation in the S1404 trial "A Phase III Randomized Trial Comparing Physician/Patient Choice of Either High Dose Interferon or Ipilimumab to MK-3475 (Pembrolizumab) in Patients with High Risk Resected Melanoma." This is a registration-intent trial that the study sponsor will submit to the Food and Drug Administration (FDA) next year; as such, it is vital that the SWOG Data Operations Center monitor expected data more closely, and ensure all data are submitted as soon as possible.


**Your site has a total of 76 outstanding queries on S1404 as of September 19, 2017, as reported by the Data Quality Portal (DQP) on CTSU.org. This value includes queries from Data Managers, non-conformant data errors, and system queries.** Please work with your study team to ensure that this backlog of outstanding data submissions is addressed promptly as all current and future queries must be addressed and closed prior to FDA submission.

Additional information will be released in the near future regarding how S1404 preparation for FDA submission will impact sites, and an automated email will be sent frequently detailing overdue data. In the meanwhile, your site staff's time and contributions to this important trial are greatly appreciated.

# Baseline Smoking Status

- NCI expressed interest in collecting baseline smoking status data
  - Some SWOG protocols already collect this, so we plan to incorporate for all new studies
    1. Future planning of potential prevention studies perhaps in smoking cessation
    2. Additional risk factor analyses for all studies
- First study to implement will be S1612 (Leukemia)


#### CRA Workbench Design Change

Welcome to the new look of your SWOG CRA Workbench! We have updated the workbench to make a number of different changes to better support users both from within the SWOG Membership, and members of our partner organizations as well. There is now only one version of the CRA Workbench (formerly there was one for SWOG and one for non-SWOG). Those users who are non-SWOG members will now have access to the same information as SWOG members. Those institutions that registered patients to SWOG studies as both a SWOG member and as a non-SWOG member, will now have access to both sets of reports in one place; these reports are now identified by your CTEP ID rather than your SWOG institution code. Some Reports will show all the data for your institution regardless of which Network Group was credited with the registration; others will be have the patients reported separately.

Some of the content has been shifted around or updated, but we are hopeful that everything will be easy to find.

# Queries in RAVE

- Marking Groups: Site from DM, Site from Auditor, etc.
- Implement additional query tracking in RAVE vs. email
- Nationwide:
  - Queries specific to specimens submitted to the solid tumor, myeloma and lymphoma repository
  - Pilot Study – S1201
- SAEs:
  - Queries specific to missing or additional documentation specific to SAE reporting
- Clinical Monitoring:
  - Queries specific to CM review on validated studies
